


# Life and Dignity of the Human Person

## Catholic Social Teaching Working Group



**GOAL:** The Catholic Women's League of Canada addresses and supports Catholic social teaching through advocacy.

**STRATEGY:** Empower members by providing educational opportunities to learn more about Catholic social teaching.



## Introduction

The very first story in the bible is the creation story. The climax of creation on the sixth day is when God creates humankind in His image, “... in the image of God he created them; male and female he created them” (Gen 1:27). God gave life to all creatures on earth, yet it was only humankind that He made in His image. “See what the love the Father has given us, that we should be called children of God; and that is what we are” (1 John 3:1).

Human life is sacred because people were created by God, and they remain in a relationship with God. Where or when people are born, how rich or poor they are and what role they play in society does not

alter this situation. Human dignity is not something another person can bestow or take away from another. It is an inherent part of being created by a loving God.

The sacred dignity of life, bestowed on Catholics by their creator, is one seven key principles of Catholic social teaching and the foundation of a moral vision for society. Yet, in modern society, human life is all too often under attack through abortion, euthanasia, use of the death penalty, abuse of fellow humans in trafficking situations, environmental degradation, intentional attacks on civilians during war, cloning and embryonic stem cell research, to name a few.

As Catholics, members are called upon to uphold the right and dignity of each person regardless of who they may be or what limitations they may have. Pope St. John Paul II wrote in his encyclical *Evangelium Vitae*,

In a special way, believers in Christ must defend and promote this right [the sacredness of human life from its very beginning until its end], aware as they are of the wonderful truth recalled by the Second Vatican Council: “By his incarnation the Son of God has united himself in some fashion with every human being.” This saving event reveals to humanity not only the boundless love of God who “so loved the world that he gave his only Son” (Jn 3:16), but also the incomparable value of every human person.

This document will provide some tools and resources that councils need to be a voice in the world for the sacredness and dignity of life and to spread the understanding that people are more important than objects. Together, members will weigh each situation and examine every institution to see whether it threatens or enhances life and the dignity of the human person and will act with justice.

It is gravely opposed to the moral law when this is done with the thought of possibly inducing an abortion, depending upon the results: a diagnosis must not be the equivalent of a death sentence.’”</p>

**Abby Johnson:** pro-life activist, spokesperson and author

Birth: July 10, 1980

Abby Johnson is an American former clinic director of Planned Parenthood who resigned after witnessing an abortion on ultrasound. She has written two books *Unplanned* and *The Walls are Talking: Former Abortion Clinic Workers Tell Their Stories*. She also founded And Then There Were None, a non-profit organization that helps people who once worked in the abortion industry find new employment.



**Benjamin Lay:** Quaker Abolitionist

Benjamin Lay was born in 1682 to Quaker parents in Copford, England, near Colchester. As a merchant, he moved to Barbados in 1718, where he became exposed to the cruel practices of slavery and human trafficking through which many profited. He became very unpopular as he spoke out against these widely accepted practices. He did not believe humans were superior to non-human animals and protested against slavery by creating his own clothes to boycott the slave labour industry. He would not wear nor eat anything made from the loss of animal life or provided by slave labour. He continued his opposition to slavery and the human trafficking industry when he moved to the United States. However, as his position was in opposition to Quakers and most other Christians, he was unwelcome in many circles.

A prolific writer, Benjamin Lay published more than 200 pamphlets on slavery, capital punishment, the prison system and the moneyed Pennsylvania Quaker elite. He died in 1759, but his legacy continued to motivate the abolitionist movement throughout the early and mid-19th century, inspiring abolitionist Quakers to keep pictures of him in their homes.





**Chief Dan George:** a poet, author, activist and professor

Birth: July 24, 1899    Death: September 23, 1981

An easily recognized face in Canada, Chief Dan George was one of the first activists for Indigenous rights in Canada. He sought to increase understanding of the First Nations people among non-aboriginal Canadians. At the 1967 celebration of the Canadian centennial, he used his poem “Lament for Confederation” to draw attention to the European colonization of Canada.

**Sr. Helen Prejean, CSJ:** advocate for the abolition of the death penalty


Birth: April 21, 1939

**St. Gianna Beretta Molla:** an Italian pediatrician

Gianna Beretta Molla was both a trained doctor and surgeon. She specialized in working with children and was drawn toward those on the fringe of society. A faithful supporter of Catholic social teaching, she generously served with Catholic Action, a group that promotes Christian values. She was a wife and mother of four. During her pregnancy with her fourth child, she discovered she had a tumour and when given the options for treatment, she chose the option that would save her baby's life. She died after delivering her fourth child.

Death: August 14, 1941


Feast Day: August 14

Maximilian Kolbe had a strong devotion to the Immaculate Virgin Mary. He received a vision from her where she offered him two crowns—a white crown that symbolized he should persevere in purity and a red crown that suggested he would be a martyr. Graciously, he accepted them both. He is best known for volunteering to take the place of another Auschwitz prisoner family man, who was sentenced to death by starvation.

**William Wilberforce:** lawyer and member of the British parliament

Birth: August 24, 1759    Death: July 29, 1833

During the Easter season of 1786, William Wilberforce experienced a spiritual rebirth and began to live as a serious Christian, abstaining from alcohol and re-accessing his political life. He became absorbed in the issue of slavery and began to work towards its abolition. In 1807 the British Empire abolished slavery due in part to his work, Thomas Clarkson and others.
